## 5. MEMBERSHIP:

### Qualification to become Members:

The membership of the society will be given to any Indian citizen who:

- i. He/She has attained the age of eighteen years.
- ii. Promises to abide by the rules and bye-laws and all the decisions taken by the association in respect of the amendments of the rules and bye-laws.
- iii. Subscribed in writing to carry out to the best of his /her capacity the objects of the association.
- iv. He/she should be free from all anti-social activities and should be physically and mentally fit.

### v. Subscription, Donation etc:

All the members liable to subscribe lump-sum amount as membership fees/subscription or donation. He may also liable to subscribe towards the society so fixed by general meeting time to time.

### vi. Collection of fund:

The fund of the Society will be collected from membership subscription/fees, donation from members/well-wishers, grants from Govt. organization, private companies and from its own resources, if any.

### vii. Control of fund:

A Bank Account will be opened in the name of the society in a Nationalized Bank/Corporate Bank/Scheduled Bank or Post Office, which shall be operated jointly by President and Secretary of the Society or as decided by the committee. The Executive body has given the fully Signatory Authority either Secretary or President, to deals any function of the society, as-FCRA matter any work, fund transaction of Banking sector, any Govt aided fund of the LOTUS N.G.O.

## 6. PROCEDURE OF THE GENERAL MEETING:

The General Meeting will be held at least once in a year. All the members will be intimated fifteen days before the date of commencement of the meeting by the secretary/ convener to attend the meeting positively. The meeting will be presided over by the president. In absence of president the vice president/Secretary will preside over the meeting or as selected by the members present in the meeting.

## 7. QUORUM OF THE GENERAL MEETING:

In presence of 2/3rd members of the total members, the quorum of the General Meeting will be formed, but no quorum in case of adjourned meeting is needed so far.

## 8. ELECTION PROCEDURE OF THE EXECUTIVE COMMITTEE:

The Executive Committee will be constituted through democratic procedure from amongst the member of the Society in any general meeting.

## 9. SHORT DESCRIPTION OF THE EXECUTIVE COMMITTEE:

At present there are 7 members in the executive body one President, One Secretary, one Treasurer and others are Executive Members subject to increase in due course if felt necessary.

**10. THE TERM OF THE EXECUTIVE COMMITTEE:**

The term of the Executive Committee will be 3 (three) years, subject to increase or decrease in due course if felt required.

**11. PROCEDURE OF RE- ELECTION OF THE MEMBERS OF THE EXECUTIVE COMMITTEE:**

If necessary, Re-election will be held according to the election procedure. All the members will be intimated before 15 days of the date fixed to discuss the matter of re-election of selection of the members for constituting the executive body from amongst the members in support of the members present in the meeting and as per resolution adopted in the meeting.

**12. PROCEDURE OF THE MEETING OF THE EXECUTIVE COMMITTEE:**

The Executive Committee will be held at least once in every two months or so for smooth functioning and management of the Society. If necessary emergency meeting may be called and the members will be intimated in due course 15 days ahead of the meeting to attend the meeting to discuss the matter for which the emergency meeting is called for.

**13. QUORUM OF THE MEETING OF THE EXECUTIVE COMMITTEE:**

In pursuance of 2/3<sup>rd</sup> members of the total Executive members, the quorum of the executive Committee will be formed, but quorum in case of adjourned meeting does not arise.

**14. EXPULSION OF UNDESIRABLE MEMBER:**

If any member goes against the Regulation of the Society, then the same member will be suspended/ expelled from the Society.

**15. AUDITOR:**

A qualified Auditor will be appointed by the Executive Committee for a term of one year, who shall audit the accounts of the Society at least once in a year and the Annual Audit Report will be submitted to the Registrar of Society Regularly.

**16. LEGAL PROCEDURE:**

According to the provision laid down in the section 6 of the societies Registration Act-XXI of 1860, the Society may sue or may be sued in the name of the President and Secretary of the Society.

**17. DISTRIBUTION OF PROFITS / ASSETS ETC:**

The members are not entitled for any remuneration. They shall however be entitled to be reimbursed all travelling expense incurred by them in the course of discharging the function of society. Any income by way of generation from projects as per the aims and objectives, donations & grant-in-aid, subscription, etc. of the society will be fully utilized for the purpose of the society and will not in any way or form, i.e. kind, cash, gifts, profits, interest, dividend or otherwise will be made to any of the members who associated with the society presently or was associated previously and their relatives.
